ANTI-RAGGING CELL

As per the UGC notification in regard to prevention and prohibition of ragging in Higher Education Institutions, the College has constituted the Anti-Ragging Committee to prohibit, prevent and eliminate ragging on the College campus. Ragging is a criminal offense. Ragging is strictly prohibited by both State Govt. and Central Govt. Punishment for ragging will be as follows:

- (i) Imprisonment up to three years and fine of Rs.10,000/-
- (ii) Dismissal from the college

Ragging has ruined countless innocent lives and careers. It is now defined as an act that violates or is perceived to violate an individual student's dignity. Ragging is totally banned in the campus and anyone found guilty of ragging and/or helping ragging is liable to be punished as it is criminal offence. CWC, Clara's College of Education, ensures strict compliance on the prevention of Ragging in all the forms.

Responsibilities

- ✚ To conduct an on-the-spot enquiry into any incident of ragging referred to it by the faculty or student or parent or guardian, as the case may be: and the enquiry report along with recommendations shall be submitted to the Head of the Institution for action.
- ✚ To offer services of counselling and create awareness to the students.
